Sir,

In producing herewith one (01) arrested accused person. who disclosed his name & identity as Md. Ajju [23 yrs] S/O- Md. Ajad of Quraishi Mohalla, Ward No- 6, PS- Siliguri, Dist- Darjeeling. I SI Gopal Ch. Mandal of Siliguri PS/ SPC do hereby lodge this complaint to the effect that, on 03.05.2021 at 14.05 hrs during my picket duty at Venus more area found the above noted person along with one Asif Qureshi S/O- Ekbal Qureshi and 50/60 others gathered at Hill Cart Road Dangipara, Pan Palace Galli, PS- Siliguri, Dist- Darjeeling were gathered there without wearing mask on their face, without maintaining social distancing and without any proper reason. On being asked, the above noted persons stated before me that, they were well aware of the present pandemic situation and they supposed to remain in home and not to come out without wearing mask on their face. I told them to left them but they did not pay any heed.

Hence, they violated the order for combating the spread of COVID-19 as per order of Govt. of West Bengal vide order no-79-CS/2020 dated 12.04.2020, notification no- 347-I.S.S/2M-24/2020 dated 03.06.2020 and Memo no- 486-CS/2021 dated 24.04.2021 in view of break-out of pandemic COVID-19 throughout the country as well as the State. However, I arrested the above noted accused person u/s- 41 Cr.P.C in c/w the case and others were manege to fled away from the spot.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused person and Asif Qureshi S/O- Ekbal Qureshi and 50/60 others and arrange for proper investigation of the case.
