Asej came to us and started abusing and threatening us citing the recent election results, on asking them to leave they took out steel rods and knives and called around 50 men from their locality who then started a fight and pelted stones at our house.

Sir, we feel very unsafe and threatened by such hoodliganism in broad daylight in the middle of the town.

I request you to take strict and harsh action on these aforesaid hoodligans as soon as possible.
