I would like to bring this matter to your notice that after the declaration of Bihar Sabha Poll result 2021. Some miscreants and supporters of BJP party tried to disrupt peace and tranquility of our locality. Today around at 2pm Vijay Gupta, Vinay Prasad, Sumit Prasad and their supporters of Sonar Pally Comms near my scooter and torn CM Mamta Banerjee's sticker which is stuck at my scooter's front side. and created a mob and chanted a particular religious slogan and started hitting with bamboo stick and iron ~~rods~~ rods, glass bottles and pelted stones to the innocent people of Quraishi Mohalla, before the victims could understand the situation, they started running for safe shelter around them. Before the mob they provoked the minority locals of the area with hate gesture and slogans, chanted "Jai Shree Ram" "BJP Jindabad" repeatedly.

Finally at around 2:45pm Police arrived at the spot and dispersed the crowd.

Sir, I request a proper inquiry and appeal the Police officials for meritorious actions against the communal mobster and BJP supporters.
