Dear Sir,

I, Smt Anjali Debnath, Wife of Late Anil Chandra Debnath, resident of Udham Singh Sarani, Punjabi Para, Post Office & Police Station- Siliguri, District-Darjeeling, would like to inform you that during the lifetime of my husnand Late Anil Chandra Debnath, he purchased a plot of land measuring 0.06 acres recorded in Khatian No. 5275 comprised in Plot No.9679, J.L. No.110, Touzi No.3(Ja), situated within Mouza- Siliguri, District-Darjeeling by virtue of a registered Deed of Conveyance being No. 6864 for the year 1978.

On 27.02.1995 my husband died intestate leaving behind me and my sons namely Sri Samir Debnath, Sri Gopal Debnath and Sri Gautam Debnath as his legal heirs and successors. In the year 2002 my three sons as mentioned above have gifted and transferred their respective shares in the above mentioned property to and in favour of me by executing a Deed of Gift recorded in Book No.1, Volume No.56, pages from 163 to 168 being No.2288 for the year 2002. Thereafter, I planned to construct a G+2 residential building thereon. Accordinly my younger son, Gautam Debnath took a financial accommodation from Axis Bank, Siliguri Branch in which I stood as a co-borrower of the same. Subsequently with the active financial participation of my younger son Gautam Debnath I have managed to construct the ground floor and the first floor of the G+2 residential building thereon. It is pertinent to mention here that a portion of the ground floor of the building is allocated as Godown and a common space for using the staircase and I am using and occupying a 2BHK flat situated at the first floor and my son, Gopal Debnath is using and occupying another 2BHK flat situated

Sir, the property belongs to me and I have every right to enjoy my constitutional right to property which my son Gopal Debnath is forcefully trying to snatch away from me. I have told him several times to quit and vacate my property but he is forcefully occupying the property and at the same time torturing me mentally and physically everyday. Being an old aged lady and senior citizen and moreover being a mother it is very unfortunate for me to be assaulted by my own son.

I am living in constant fear of my life. I therefore request you to kindly take strict action against my son Gopal Debnath and his wife Chaina Debnath and do the needful so that they leave my house and so that I may live peacefully without being tortured regularly.
