Sub.-complaint against the Driver of of unknown Ambulance.

Respected sir,

I Tapan Sarkar aged 42 yrs s/o Sunil Sarkar resident of Adharsha Nagar Colony, ward no. 4, PS Siliguri, would like to inform you that while heading back home riding on my motorcycle, bearing no WB 74AN 0750, one ambulance (unknown number coming from opposite direction) hit me and absconded, for which I got serious injury. During the incident I couldn't read the number of the vehicle. I could only notice it was an ambulance. The incident occurred at Flyover near your police station at around 2100hrs on Sunday dated 02/05/2021, some unidentified uniform police personnel from your police station had also gathered, escorted me and taken to Siliguri Sadar Hospital and later I was referred to Medica Nursing Home, Pradhan Nagar, Siliguri.

Now I am under medical treatment at Medica Nursing Home. One of my right leg has totally broken and had to go under major surgery.

This is further to note sir I couldn't lodge this complaint as it was late evening and my physical condition was unstable and I was under acute physical pain.

I therefore request you sir, considering the above facts and circumstances my written complaint may kindly be accepted and your kind necessary legal action under proper section of law may kindly be initiated against the unknown offender of the mentioned vehicle.
