In producing herewith 03 (Three) arrested accused persons who disclosed their identity as 1) Biplab Ghosh S/o Lt Suren Ch Ghosh of Bhaktinagar, near Ghosh Nursing Home, PS- NJP, Dist- Jalpaiguri (2) Paban Ghosh S/o Lt. Bhuban Ghosh of Bhaktinagar Near Central Bank PS- NJP, Dist- Jalpaiguri (3) Avijit Poddar S/o Ashok Poddar of Bhaktinagar Near Pipe Line, P.S- NJP, Dist- Jalpaiguri

I SI Goutam Mallik of New Jalpaiguri Police Station, SPC do here by lodge this written complaint against the above noted persons to the effect that while on performing evening mobile Van duty myself along with officer and forces had been to in front of NJP Railway Station in between 23:15 hrs to 23:50 hrs. and found that the above noted persons are gathered there without any reason and found them without wearing mask. There by making unnecessary gathering in front of NJP Railway Station. On being asked the above noted persons stated before me that they were well aware of Govt. Order regarding pandemic situation of Covid-19 and wearing of facial mask has been mandatory in public places in the current pandemic disaster situation.

They all violated the order of Govt. of West Bengal vide Memo No. 486-CS/2021 dt. 24.04.2021. Hence I arrested them in c/w the case under proper memo of arrest in between 23:15 hrs to 23:50 hrs duly signed by them in presence of witnesses inform the ground of arrest.

Now I request you for starting a specific case U/S 188/269/270 IPC r/w sec 51 (b) of disaster Management Act.2005 against the above noted accused persons and arrange proper investigation of the case.
