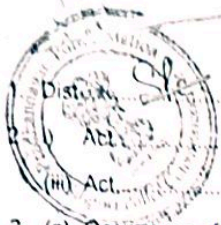

In producing here with the following 03 (Three) arrested persons who disclosed their name & identity as 1. Pankaj Sharma (26) S/o Binod Sharma of Gurung Basti, Pradhan Nagar, Darjeeling 2. Mohit Kumar (18) s/o Hari Narayan Kumar of Gurun Basti, Pradhan Nagar, Darjeeling 3. Niranjan Mondal (47) S/o Nimai Mondal of Samar Nagar, Champasari, Pradhan Nagar, Darjeeling. I PSI Youel Lepcha of Pradhan Nagar Police Station under Siuliguri Police Commissionerate do here by lodge this complaint to the effect that today i.e 07.05.2021 in between 18:35 hrs to 19:30 hrs myself along with ASI Raju Sarkar, ASI Anup Sarkar, ASI Binod Jha and other force had been to Siliguri Junction, Siliguri and found the above noted persons were gathered there without wearing mask on their face and without maintaining social distancing and also without any proper reason.

On being asked the above noted persons stated before me that they had well to aware of the pandemic situation and they supposed to remain in home and not to come out without wearing MASK on face.

Hence , they violated the order for combating the spread of COVID- 19 as per order of Govt of West- Bengal vide order No 79-CS/2020 dated 12.04.2020 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June ,2020 and Memo No 486-CS/2021 dated 24th April , 2021 in view of break-out of pandemic COVID-19 throughout the country as well as State . Accordingly, I arrested them u/s 41 CR.P.C in c/w the above case.

Now, I request you for starting a case u/s 188/269 IPC R/W Sec 51 (b) Disaster Management Act, 2005 against the above noted arrested persons and arranged to proper investigation of the case.
