Respected Madam,

With due regards, I, **SMT POONAM DAS GUPTA**, Wife of Sri Arunjoyti Das, Daughter of Late Rajnarayan Gupta, Resident of Swami Sarani, Scond by Lane, Hakim Para, Ward No. 15, Siliguri, P.O. & P.S Siliguri, Dist: Darjeeling, in the state of West Bengal would like to lodge this written complain to the effect of my marriage solemnized on 30.05.2009 at Kalimandir at Guwahati, Assam with Sri Arunjoyti Das, Son of Sri Amal Kumar Das of Ramoni Sagar Road, Madan Mohan Akra, Karimganj, P.S: Karimganj in the state of Assam according to Hindu Rites and Customs. Sometime later of our marriage we shifted to Siliguri as he joined a company named Abbott Company as Territory Business Manager (T.B.M) which was situated in Siliguri and started to reside at the house of the Pradip Debnath at "DINESH NEER", situated at Suchitra Paul Sarani, Haiderpara, ward no 39 P.S: Bhaktinagar. In the years 2015 as I was pregnant with my Child there was a sudden change in his behaviour and attitude towards me. He started neglecting me and refused to take care of me so much so that he started picking up quarrels on any tripling issues. With the instigation of my father-in-law, Sri Amal Kumar Das and my mother-in-law Smt. Shampa Das, he tortured me mentally and physically. He started misbehaving with me and started to maintain distance from me, he preferred staying major portion of his time outside the house and kept avoiding any kind of communication with me. Other than expenses on food, he also stopped paying for my basic expenses as required which was required by me in such delicate period of my life. On 11.04.2016 when my daughter Miss Aradhya Das was born he and his family members were extremely unhappy with the birth of a baby girl and his torture manifolded as he even refused to take care of my daughter who is a special child having a deformity of club-foot. Hence the responsibility to take of my daughter fell upon me alone. Due to the deformity huge expenses is required for her extensive medical treatment in Patna. However my husband was least bothered about the health of our daughter and did not pay the rest of the money which is required as her leg is kept under supervision, the expenses of which is borne solely by me. He continued torturing my daughter and me even during these tough times. He is heavily under the influence of alcoholism and is addicted drugs also

parties late night with his friends completely ignoring my ill daughter and me. He used the threaten me to face dire consequences if I take any legal steps against him. He always blamed me for giving birth to a girl child and a child with deformity. He never paid any heed to me and daughter and continued torturing me mentally and physically. He also stopped financially maintaining us completely. Suddenly a day in the month of March 2021, my mother-in-law and my father-in law went to Assam for few days. After few days my husband told me that he will go to meet his parents and kept me at my sister's place at Siliguri. But after few days I came to know that the house where we resided is vacated by my husband and he left me and my child without any intimation. When I asked him about his whereabouts over the phone, he refused to provide me with any information and threatened me of dire consequences also stopped providing any kind of maintenance as required by me and my minor daughter. Madam I am a victim of prolonged Domestic Violence caused by my husband and I along with my daughter are passing our days in extreme fear and anxiety.

Therefore Madam, I will be highly grateful to you if you investigate into the matter and kindly please take appropriate strong legal action against my husband as per the provision of law and oblige me thereby.
