
Sub: Diary for Theft and cutting of rod at an under-construction building

I Shyam Sundar Agarwal s/o Late Maniram Agarwal resident of Agrasen Road, Khalpara, Siliguri is writing to lodge a complaint regarding three miscreants who have cut and stolen TMT rods from my under construction building at Bholanath Para, Baneshwar More, Behind Shiv Shakti Traders, Eastern Bypass, Siliguri thus damaging the building.

On the night of 29<sup>th</sup> April 2021, three miscreants namely Ravi Rai s/o Chaitu Rai, Kamal and Janak who are son-in-laws of Chaitu Rai, residing at Bholanath Para, Baneshwar More, Eastern Bypass, Siliguri entered the locked premises, cut and stole top floor pillar rods, rods left on the backside as well as other areas and cable wires, thus damaging and hindering further construction of the building. I came to know about this information from the villagers itself who saw them stealing at night and also stopped them. They have caused a considerable damage to the building which is irreparable.

I kindly request you to conduct an enquiry and take strict action against them.
