I Sri B.K. Mishra Manager of Bajaj Express (India) PVT LTD having its office at Shelcon Plaza building. Sevoke Road Siliguri beg to report you that as per consignment No - 1)SLG-74533 2) SLG-74534 3JSLG-74538 we had to Send 632 bags of tea to the consignee Jay Shree tea & Industries LTD . Koikata after lifting from different tea warehouse of Siliguri in which Delivery order of 192 bags of tea handed over to Mr Shatrudhan Kumar Ray S/O late Parichhan Ray of Gandhi Nagar behind Bhagwati Club PS Bhaktinagar Dist-Jalpaiguri on 05-05-2021 who is involved in the business of Supplying vehicle for lifting goods in local -area . Mr Shatrudhan Kumar Ray had supplied his two vehicle bearing . 1) Regestration No-WB73E-8117 (Mahindra pick up) and 2) Regestration No-WB73E-2480 (TATA ACI. [EMPO] for lifting purpose.

Among the Said two vehicle one vehicle bearing Registration No-Wb73F-8117 (Mahindra pick up) had properly Collected 114 bags of tea and dropped to our godown Situated at 2nd1/2 mile Sevoke Road OPP Maruti kata behind Relience Market but another vehicle bearing Regestration No-WB73E-2480 (TATA ACE TEMPO) which was being driven by driver namely Sunray who lifted 78 begs of tea from KAMAL TEWARI & SONS AND KAMAL TEWARI TEA WAREHOUSE PVT LTD (TEA WAREHOUSE) (Gate pass attch)did not reach at our godown till 8 PM we then informed the matter to Said Mr Shatrudhan Kumar Ray. In late night Mr Shatrudhan Kumar Ray informed that the vehicle along with Said 78 Bags of tea was missing and the driver was also missing.

At about 10 PM one of my godown staff namely Baljeet on the way to his godown could see the Said Missing vehicle i,e TATA ACE Tempo standing unclaimed and empty near Relience market which is informt of our godown. We instantly approached the place and made enquiry in the locality. One said that the vehicle was lying there since 2:30 PM and the driver after placing the vehicle had left boarding in passanger auto.
