**Subject; Brutal torture and Physical assault upon me by my step son and daughter-in-law outraging of modesty Krishala Rai one of my tenant on demand of transferring the ownership of the residential house and theft away of gold ornaments and cash.**

In connection with the above I Gita Paul, Wife of Late Ajit Kumar Paul resident of 'Shipra Bhavan' 46, Bankim Chandra Road, Hakimpara, P.O. & P.S. Siliguri, Dist. Darjeeling, within Siliguri Municipal Corporation Ward No. XV would like to state that I am the legally married wife of Ajit Kumar Paul (Since deceased) and my marriage was solemnized 34 years back with him. Prior to my marriage with him my husband Ajit Kumar Paul (since deceased) was married to Shipra Paul and out of the said wedlock they had One daughter namely Shampa Ghosh Nee Paul and One son namely Ranjan Paul @ Bappa. After the demise of said Shipra Paul I got married to my husband Ajit Kumar Paul (Since deceased). Out of the wedlock with my husband Ajit Kumar Paul (Since deceased) I have one daughter namely Kuntala Sen nee Paul. My husband alongwith his first wife Shipra Paul was the absolute joint owner of a residential house premises at the address mentioned above and my husband has gifted his  $\frac{1}{2}$  share in the said residential house to and in favour of me within specific demarcation and as such I became the absolute owner of the said part and portion of the residential house and I have been occupying, possessing and living in the said part and portion of the residential house and my

step son Ranjan Paul @ Bappa is living in another portion of the said residential house. That my step daughters as well as my own daughter both are married and live in their respective matrimonial home at Siliguri and Hyderabad respectively. As such I stay alone in my house and as I have no income of my own I have let out a portion of the said house to earn my livelihood and living. That my step son with an intention to grab the residential house is/was torturing me both physically and mentally since a long and I have lodged several complaints before the Councilor of our Ward as well as to the police authority as against him previously but no cogent action has been taken as against my step son as such his courage to torture me to oust me from the residential house and to grab the entire property is increasing day by day. My step son also threatens my tenants to leave the tenanted premises knowing fully well that if those tenants will leave I will be not be able to subsist. It is also pertinent to mention here that my step son has married thrice and presently is married to one Tulsi Paul. Today at around 9:00 a.m. my said step son and daughter-in-law intentionally started abusing me without any rhyme and reason and both of them assaulted me physically with fist and blows and ransacked my house and snatched away my gold ornaments from my steel almirah and cash of a sum of Rs. 10,000/- (Rupees Ten Thousand only) threatened my tenants to quit and vacate the property. My step son has also physically assaulted one of my tenants Krishala Rai, Sri. Maitra Rai resident of Uttar Purba Shelpur, Village-Shittong-3, P.O. Shelpu, P.S. Kurseong, Dist. Darjeeling, Pin: 734008 aged about 25 years and have torn her cloths and outraged her modesty and have thrown away her articles from the room. Due to such assault I as well as my tenant aforementioned sustained injuries. My step son and daughter-in-law has been carrying on such torture since a long and on regular basis with the sole intention to grab the entire



property. I am an old aged lady and I am passing each days in fear of being assaulted and tortured by my aforementioned step son and daughter-in-law and they have also threatened to kill me.

Under the above circumstances I hereby lodge this complaint against my step son Ranjan Paul @ Bappa and my daughter-in-law Tulsi Paul for assaulting me and my tenant Krishala Rai and outraging her modesty as well as stealing/theft away of my gold ornaments and cash of a sum of Rs. 10,000/- (Rupees Ten Thousand only) from my dwelling house and ransacking my house and would request you to investigate the matter so that the wrong-doers can be punished as per law.
