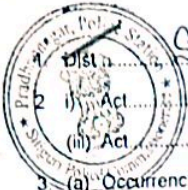

Sir,

In producing herewith the following 03 (three) arrested persons who disclosed their name & identity as 1)Sanjay Rauth (35yrs) s/O Rambilash Rauth of S.B Day Semotoruim Down Hill PS Kursoung dist Darjeeling , (2) Chandan Basfore (47 yrs) of B.R.I Colony near Durga Puja Math ,PS-Pradhanangar, Dist- Darjeeling, 3) Surendra Rauth (37 yrs) S/O Lt. Sukhey Rauth of Daragoan GP-1 PS –Jaigoan Dist- Alipurduar. I SI Binup Mahato of Pradhan Nagar Police Station under Siuliguri Police Commissionerate do her by lodge this complaint to the effect that today i.e 10.05.2021 at 23:45 hrs myself along with ASI Debashish Das, ASI Ratan Pradhan and other forces of Pradhannagar Police Station had been to B.R.I Colony area and found the above noted persons were gathered there without wearing mask on their face and without maintaining social distancing without any reason.

On being asked the above noted persons stated before me that they were well aware of the pandemic situation and they were supposed to remain at home and not to come out without wearing MASK on face.

Hence, they violated the order for combating the spread of COVID- 19 promulgated by Govt of West- Bengal vide order No 79-CS/2020 dated 12.04.2020 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 in view of break-out of pandemic COVID-19 throughout the country as well as State. Accordingly, I arrested them u/s 41 Cr.P.C in c/w the above case.

Therefore, I request you to start a case u/s 188/269 IPC R/W Sec 51 (b) Disaster Management Act, 2005 against the above noted arrested persons and arranged to proper investigation of the case.
