Sub: Threatened dispossession of our land at Mouza Baragharia, P.S. - Matigara, within Patharghata Gram Panchayat, District Darjeeling by Mrs Shila Rani Dey and her associates.

Dear Sir,

I refer to our earlier complaint dated 12.10.2018.

I am writing as the constituted attorney of i. Sri Ashok Kumar Agarwala, son of Keshari Chand Agarwala, ii. Sri Hridesh Agarwala, son of Manohar Agarwala and iii. Sri Ajay Agarwala, son of Bhagwandass Agarwala, the residents of Hill Cart Road, Siliguri, District Darjeeling, in the State of West Bengal to lodge the following complaint:

1. By a registered deed no. 354, dated 13.08.1997, registered at the office of the District Sub-Registrar, Darjeeling, i. Sri Ashok Kumar Agarwala ii. Sri Hridesh Agarwala and iii. Sri Ajay Agarwala purchased and became the absolute joint owners of all that piece and parcel of land measuring 2.36 acre being recorded in 179 and 180 corresponding to their Khatian Nos. 263, 264 and 265 situated within Mouza- Baragharia, J.L. No. 82, P.S. - Matigara, within Patharghata Gram Panchayat, District Darjeeling
2. Ever since the purchase, they have been in absolute physical possession and exclusive occupation of the said land measuring 2.36 acre and being such owners, they also got their respective names recorded into the L.R. records at the office of the B.L. & L.R.O., Matigara at Shivmandir and three separate L.R. Khatians were opened in their respective names bearing L.R. Khatian numbers 263 [in the name of Sri Ashok Kumar Agarwala comprising area measuring 0.79 acres], 264 [in the name of Hridesh Agarwala comprising area measuring 0.79 acres] and 265 [Ajay Agarwala comprising area measuring 0.79 acres].
3. I regret to inform you that one Mrs Shila Rai Dey, wife of late Jadeb Chandra Dey of Shivmandir Bazar, Matigara P.O., taking the help of some anti-socials of the vicinity, viz., Samir Chhetri, Tapan Roy, one Ravi, Pula Oraon, Feroj Saibo, Charoa Oraon, along with other violent criminals were regularly trespassing upon my principals' said land and trying to encroach upon the same.
4. They have been threatening us with dire consequences. We had earlier lodged the complaint referred to above but we regret to say so far no action has been taken.
5. We have come to learn that they are also making efforts to insert some false names in the records of rights illegally. It would appear that they are being financed, instigated and guided by some of the local land mafia who specialise in land grabbing and squatting and thus making fortunes out of such criminal activities.
6. It is clear that Mrs Shila Rani Dey who is making false claims to the title of the said property is using these miscreants to bypass the law and violently grab the property of my principals. These miscreants have been recently seen lurking about the property and seem to be making all sorts of preparations to forcibly enter the same permanently.


