With due respect and in producing herewith 03 (Three) persons namely (1) Bijan Mahato (20) S/O Satyanarayan mahato of Md 117 Fish market , Siliguri Regulated market , P.S-Pradhannagar, Dist. Darjeeling (2) Anirudh Sah (38) S/O Pralahad Sah of PKR , Siliguri Regulated market , P.S-Pradhannagar, Dist. Darjeeling & (3) Kalam Khan (25) S/O Lt Rasid Khan of Tiya mari, P.S-Tiya mari , Dist. Gouripur , Assam who have been arrested by me of the following ground:

That sir, today on 11.05.2021 at about 14.30 hrs an information has been received by the on duty officer of Pradhan Nagar PS that, peoples are not following COVID-19 guidelines at Regulated market area which leads to spread of virus among the public in general. Accordingly, as per order of I/C Pradhan Nagar PS myself along with ASI Debases Das, ASI Rattan Pradhan and force left PS vide PDN PS GDE No. 526 dtd. 11.05.21 to pursue the information. On reached at regulated market we found the above noted persons are roaming at the area without wearing mask, not maintaining social distance norms in the public place violating the Govt. Order No. 79-CS /2020 dtd 12.04.2021of Gove of West Bengal and Home and Hill Affairs Department of the Govt of West Bengal, vide notification number 237-I S.s /2M-24/2020 dtd 03.06.2020 and Memo no. 486-CS /2021 dtd. 24th & Chairman, State Executive Committee WBSDMA. April, 2021 of Chief Secretary Accordingly, the above noted persons was detained on being interrogated disclosed their identity as above and further failed to give any satisfactory answer regarding their such activities in that area rather they refused to comply with direction of the Government regarding spreading of COVID-19. Hence, I arrested them u/s-41 Cr.P.C, issuing copy of Memo of Arrest and informing the ground of their arrest.

Therefore, I pray before your good office that a specific case under proper section of Law may kindly be started against the above noted accused persons and arrange for its investigation.
