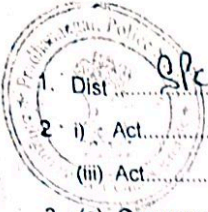

CASE SUMMERY

Name - Manish Kr Sak Age - 18⁺ y/o Sex → male.

18 y/o male patient, named Manish Kr Sak, gives alleged H/O physical assault by a group of boys. The incident took place on 9/5/2021 at around 1:30 PM, while he was playing cricket with his friends and brother. While his brother was being beaten by a group of boys, he also got beaten in order to rescue him. Manish alleges that a group of 15-20 boys beat him from behind with wicket and he got unconscious. He was taken to Siliguri District Hospital, where a cut injury of 2cm over his right parital area was sutured, and he was shifted to Mukherjee Hospital for better management. After patient's admission here, the following things were seen.

- Although patient complained of bleeding per month after the incident, but no active bleeding was seen here.
- Patient was admitted here and is being given supportive treatment with Oxygen, IV fluids, antibiotics and other drugs.
