1. One Tailor (heavy goods vehicle) bearing registration no PB23J 5851 having engine no 01H62919858 and chassis no MAT 447206 A2H20957,

2. 50 (fifty) cases Imperial blue containing 24 pieces each, embossed sticker as authentic grain

3. 59 (fifty nine) cases Royal Stag containing 24 pieces each, embossed sticker as classic whisky, 375 ml each, totalling 1416 bottles as per seizure list (annexed herewith)

I S.I. Mrityunjoy Roy of Detective Department, Siliguri Police Commissionerate do hereby lodge this written complaint against above noted accused persons to the effect that today on 13.05.21 at 13.15 hrs,I received a secret intelligence that the driver of above noted vehicle laden with spurious alcohol of various foreign liquors has got their vehicle parked at Debidanga Bazar under PS - Pradhan Nagar, SPC. An organized racket of unscrupulous antisocial is involved in smuggling such liquor clandestinely. Having taken lunch, they will leave Debidanga for selling such liquor illegally without license in Bihar. Accordingly, I informed the matter to ACP, D.D SPC. Later, the information was diarized vide D.D, SPC GDE No- 45 dt- 13.05.21, and as per his kind direction, myself along with Const- 945 Krishna Barman, Const-1054 Arabinda Roy and Const driver - 598 Shibu Das left for Matigara area to verify the veracity of the source information. This refers to D.D, SPC GDE No- 45 dt 13.05.21 and DD SPC CC No 103/21 dt 13/05/21. I then arrived at Palpara near Balasan bridge at around 14.05 hrs. On reaching there, I called two disinterested witnesses namely (i) Joyanta Singha S/O Dadlal Singha of Himul PS:- Matigara Dist:- Darjeeling and ii) Jogesh Mohanta S/O Uttam mohanta of Thiknikata Medical More PS:- Matigara Dist:- Darjeeling. With time, we kept watching for the said Bagdogra bound trailer truck. Later, on intelligence parlance I detained the said truck. Although, the driver of the said vehicle tried to speed away, yet we managed to intercept the driver with vehicle and his associate. On interrogation, they failed to produce any document in support of their loaded goods. Further, they admitted that they loaded such adulterated liquor clandestinely from Milon More near Debidanga under PS Pradhannagar, SPC and possessing the same for selling these cartoons of liquors to their designed customers in Purnia, Behar in high prices and thereby they violated the provision of Bengal Excise Act. Accordingly, in the very presence of above noted witnesses, I seized the liquors from the possession of accused persons under proper seizure list duly signed by the witnesses and accused persons. The seizure was made on 13/05/21 in between 15:15 hrs to 15:45 hrs. I labeled the seized articles duly signed by the witnesses and accused persons. I then arrested the accused persons after preparing proper memo of arrest and intimated them the ground of
