Then when my driver protest then Chottelal Satani started hitting him with fist blow and Kicke and Dhan Bahadur Lonan with bamboo stick in his hand hitted me from behind and I fell down then they took 5000/-rs which was in my pocket for fueling oil tank and when local people started gathering after seeing this they flew away from there they also took Jack, lever and tools of the vehicle being no. WB 73 F 1866 and beaten the driver of that vehicle.

So, I therefore request you to

kindly take necessary legal action against said culprits.
