In producing herewith one accused person namely Goutam Roy (40) s/o Lt. Khagendra Nath Roy of North Ektiassal Khaikhai Bazar near Bartala, Word No. 40 P.S Bhaktinagar, Jalpaiguri -along with seized articles viz (1) 26 (twenty six) bottles of Himalayan Gold 60 up country spirit containing 600 ml each manufactured by Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal. (2) 5 (five) bottles of black label strong premium beer bolted by united Breweries LTD. Vittal Mallya Road, Kalyani, West Bengal havinf its regd Office UB Tower, UB City No-24 Vittal Malya Raod Banglore-560001 and (3) 10 (ten) pouch packets of Officers Choice Delux Whiskey containing 180 ml each manufactured by Allied Blenders and Distillers PVT. Ltd. Kalyani Industrial growth centre.

I, SI Sibdhan Karmakar of Bhaktinagar P.S. under Siliguri Police Commissionerate do here by lodged a written complaint against Goutam Roy s/o Lt. Khagendra Nath Roy of North Ektiassal near Bartala, Word No. 40 P.S Bhaktinagar, Jalpaiguri to the effect that today on 14/05/2021 while I was performing Special raid duty as per order of my superior vide Bhaktinagar PS GDE NO-696 date 14/05/2021, received a specific input from the source at 20:10 hrs. that the above noted person has kept huge numbers of illicit liquor in his shop at Ektiasal Khai Khai Bazar in order to clandestinely dispose the same. Accordingly the fact is informed to I/C Bhaktinagar PS and as per his direction I along with ASI Rabin Lama, C/374 Debraj Biswas, CV-619 Dharmendra Roy left for Khaikhai Bazar under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by source cordoned the shop where he kept illegal alcohol. On arriving there found the above noted person who disclosed his identity as noted above who kept the same at his shop in conceal position. On searching found huge numbers of Himalayan Gold country made spirit and other brand of illegal liquor. On being interrogation he could not produce any valid documents in respect of the said illicit liquor.. He also stated that he is doing this liquor business since last 04 months for wrongful gain. Accordingly I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 21:20 hrs to 21:45 hrs. On being asked he stated that he kept the same with a view to sale and supply at Khaikhai bazar area without any valid documents. As he has violated the norms of Bengal Excise Act as such I arrested him after observing all sorts rules for selling the said country made spirit and beer without valid license

Therefore I pray before your honour that a specific case may kindly be started against accd. Goutam Roy s/o Lt. Khagendranath Roy oNorth Ektiassal near Bartala, Word No. 40 P.S Bhaktinagar, Jalpaiguri as per proper section of law.
