Sir,

I Sri Sajjan Kumar Agarwal, Son of Late Khem Chand Agarwal, Resident of Deshbandhu Para Siliguri, being partner of "Perfect Automobiles" situated at "Maruti Sadan" sevoke road, near Bakshi Petrol pump, P.O & P.S: Siliguri, Disatrick: Drajeeling, like to inform you that I am tenant under Bimala Devi Agarwal, Deepak Kumar Agarwal, Manish Kumar Agarwal being my landlord and being owner of "Maruti Sadan" building and wherefrom I, carrying out business of automobiles and spare parts from "Perfect Automobiles" shop, situated in "Maruti Sadan" building in basement.

That on 9/5/2021 at about 5 to 5:30 P.M in evening another tenant of the building Sri Yogendra Kumar Kedia, son of sri Chhagan Lal Kedia resident of Sevoke road, Siliguri, P.O & P.S Siliguri District. Darjeeling, uprooted and pulled out two front neon signboards of my shop affixed in frontal portion of "Maruti Sadan" building.

That as it was Sunday my shop remaining closed, on getting this information I rushed to my shop and found Sri Yogendra Kumar Kedia along with his men and agent are destroying my sign boards by breaking it into pieces, after uprooting the same from frontal portion of "Maruti sadan" building.

That as I protested the above illegal act, Sri Yogendra Kumar Kedia hurled abusive and defamatory words against me and threatened me to assault me, and thereafter loaded the broken signboard in a vehicle forcefully and left the spot.

I therefore request your good self to take necessary action against Sri Yogendra Kumar Kedia and his men and agent and protect me including my property from the above person.
