Dear Sir,

I Sri. Robin Ekka S/o Ram Bilash Oraon, resident of Nabin Chandra Road, P.O. Siliguri, Dist- Darjeeling do hereby inform as follows:

1. That I am the actual owner of land measuring 6 Katha, recorded in Plot No- 4974 & 4975 vide Khatian No- 3510, mouza, Siliguri, P.O. & P.S. Siliguri, Dist- Darjeeling.
2. That I along with my family are residing over the said plot of land same from my birth. Now the above said persons are illegally tried to encroached above said land by using muscle power.
3. That on 09/01/21 at about 11a.m. they are accumulated the bricks and sand for construction over the said plot of land forcefully with the help of local goons/promoter.
4. That I immediately inform the matter to the O.C. Panitanki Outpost and they are immediately take measure and vist the P.O. and requested the above named persons for stop the construction. But at evening again they are started to construction over the said plot of land.
5. That when I alongwith my family members tried to protest such illegal act they become violent and tried to assault us. Even they threatened us with a dire consequences.
6. That we are belongs to Tribal Community as such the said plot of land is belongs to "Tribal Land" so nobody can take a possession without prior permission of Basic Under Claim office.
7. That the above named accused persons are dangerous and desperate in nature they have no regret of law.

Under the above circumstances, I hereby request you so kindly take a appropriate legal action as per provision of law.
