Siliguri Dist Darjeeling would like to submit you that above named persons are my relative and I had a disputes regarding our land among my above named persons and myself and subsequently in the month of January 2021 the said matter has settled amicably in presence of Ward Counsellor, and para people and they also divided our share equally and both parties are agreed regarding the said division.

That on 11-5-2021 at about 9:30 A.M the above named person brought a carpenter and tried to make a room in our share of my house at that time my daughter named Pinki Ram and I were tried to restrain them not to make room in our share of land but suddenly the above named persons became violent and started to hit on my daughter head, right hand and left hand by a iron rod and bricks and they also hit me on my right hand and forehead and due to hit my daughter got blood injury on her head, hand and thereafter my daughter fell on the ground and started to oozing blood from her head and they also started to break my house and ran-shake all house hold articles and after seeing this situation para people came to the spot and rescued me and my daughter from their hand and thereafter my daughter was taken to Siliguri S.D. Hospital by my grand daughter.

That my daughter was admitted in Siliguri S.d. Hospital and 7 stitched was held on my daughter's head and her situation is very critical

That yesterday I was not able to submit written complaint before you as I was busy with the treatment of my daughter.

That all the above persons are very notorious and desperate in nature if no action is taken against them they will murder my daughter and myself to thrown out from the house as they threatened me and my daughter by saying that.

Sir, I therefore request you please look into the matter and take appropriate action against them then I shall highly be obliged to you.
