Respected Sir / Madam,

I Sri Arabinda Kumar Mandal, S/oLate Ramacharitra Mandal, R/o-Subash Pally, Rana Busty, Ward No.18, P.O. Siliguri, P.S – Siliguri, Dist – Darjeeling would like to inform you that in the Month of November, 2019 my son namely Sajal Mandal met with a girl namely Laxmi Sahani, D/o. Sri Bablu Sahani @ Bhote, R/o. above noted address after met with her my son and the above noted girl exchange their phone number with each other and started to make conversation with each other on over telephone and after that their relation grow up day by day and I and my family members also several times intimated said facts to her family members i.e. Bablu Sahani @ Bhote, S/o. Dorik Sahani, Shila Devi, W/o. Sri Bablu Sahani @ Bhote, Jogia Sahani, S/o. Dorik Sahani, Rohan Sahani, S/o. Late Karka Sahani, Laxmi Sahani, W/o. Kishore Sahani, and her Grandmother R/o. above noted address and also request them to arranged their marriage ceremony and after that they also agree to arrange their marriage ceremony but at that time they told me that they need 2 (Two) months time to arranged the marriage ceremony and after that I and my family members accept the same and after expiry of 2 (Two) months when I noticed that they did not told anything about their marriage thereafter I and my family members called one meeting and said meeting held in the month of February, 2021 in presence of me and the above noted persons but during that meeting the above noted girl along with above noted persons denied to arranged marriage ceremony with my son and the above noted girl also denied to marry my son and after listening the same when I along with my family members and well wishers asked them why they denied to arranged marriage ceremony at that time they told us that they did / do not like my son now and during their relationship the above noted girl and the above noted persons took many valuable items and cash from my son and when asked them to return the same at that time the above noted persons started to threatened me and my family members with dire consequences and after the aforesaid incident my son as per instruction of me he did / does not contact with her any more and till now the marriage between my son and the above noted girl do / did not solemnized and in respect of the said issue the above noted persons always tried to quarrel with me and my family members and also passed some offensive languages in respect of me and my family members but I along with my family always tolerate the same with a hope that one day they will changed their behavior in respect of me as well as my family members but such day never come into my life.

It is important to mention here that yesterday i.e. on 12/05/2021 at about 09.45 p.m. the above noted all persons along with the some friends of Rohan Sahani namely Pintu Mandal, Raju Mandal, Bikash Paswan, Sri Suman Paswan, suddenly came to my house with a drunked condition and after coming to my house they without any reasons started to break my house and when I and my wife namely Smt Biva Mandal @ Mahato tried to protested the same at that time the above noted persons assaulted me and my wife very badly with fist and blows and forcefully break some portion of my house and at the time of the said incident the above noted persons also tried to burn my house and during that time due to mercy of god or after

listening our hue and cry my other family members namely Anita Mandal, and my son above named Sajal Mandal came to the spot tried to rescued me and my wife but during that time the above noted persons also assaulted my above mention family members very badly with fist and blows and at the time of the said incident the above noted all male persons intentionally touched the private parts of my above noted family member namely Anita Mandal and intentionally disrobe her and but due to marcy of god my other family members also came to the spot and rescued us and thereafter they took me and my above named family mebers namely Anita Mandal and Sajal Mandal at siliguri sadar hospital for treatment and we were treated there as an indoor patient and due to assaulted by them I and my above noted family members sutained multiple injuries on our whole body and it also came to my knowledged that at the time of left my house the above noted persons also told that they will come again and break my house and evict me and my other family mebers from the locality so, right now I as well as my other family members spend our days with in fear so, no other alternative way today with the help of my well wishers I lodged this written Complaint before you against the above noted persons.

Therefore, I request you be pleased to draw your kind attention in respect of my above noted written Complaint and take necessary steps save me from their bad intention as early as possible.
