Sir,

In producing herewith 02 (Two) accused persons namely 1) Md. Kadir (22) s/o Md. Tahir, of Darbhanga Tola, Near Venus More, W/No.06, PS Siliguri, Dist. Darjeeling (2) Md. Meraj (26) s/o Md. Tahir, of Darbhanga Tola, Near Venus More, W/No.06, PS Siliguri, Dist. Darjeeling under arrest.

I, SI Ashim Kr Das of Panitanki Town Out Post, PS- Siliguri, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that on 13.05.2021 at about 13:15 hrs. while performing Patrolling duty at Bidhan market area and found the above noted arrested persons were moving here and there without using face mask. On being asked they disclosed their name as 1) Md. Kadir (22) s/o Md. Tahir, of Darbhanga Tola, Near Venus More, W/No.06, PS Siliguri, Dist. Darjeeling (2) Md. Meraj (26) s/o Md. Tahir, of Darbhanga Tola, Near Venus More, W/No.06, PS Siliguri, Dist. Darjeeling.

On interrogation, it could be learnt that they had no any reason to move here and there without using facial mask during Pandemic disaster situation. Over that some of the local peoples were also annoyed with the accused persons by such an act. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving without facial mask & valid reason. They negligently and malignantly move to spread infection of any decease dangerous to life during Pandemic disaster situation.

Hence, they violated the order of the Govt. of West Bengal duly promulgated in order No 79-CS/2020 dated- 12/04/2020 and Govt of West Bengal vide notification no. 347-I.S.S/2M-24/2020 dated-03/06/2020 and Govt of West Bengal order no. 715-Home (Cons) / RIM (Cons)-92/2021 dated-17/04/2021 and Chief Secretary, Govt. of West Bengal memo no. 486-CS/2021 dated-24/04/2021. The above noted person has intentionally refused to comply with the Govt. order duly promulgated in view of break-out of pandemic COVID-19 throughout the State. Accordingly, I arrested the above noted accused persons U/S 41 Cr. P. C.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against 1) Md. Kadir (22) s/o Md. Tahir, of Darbhanga Tola, Near Venus More, W/No.06, PS Siliguri, Dist. Darjeeling (2) Md. Meraj (26) s/o Md. Tahir, of Darbhanga Tola, Near Venus More, W/No.06, PS Siliguri, Dist. Darjeeling and arrange for its investigation.
