beg. to inform you that on dt. 12.05.2021 at about
10.00 pm, when I reached at Santoshi Nagar More,
Burdwan Road, at that time, one Ratan Sarkar
s/o Not known, having his Raw Coconut etc. shop at
the footpath, on Kali Bari Road, P.S. Siliguri, along with
06 (six) other persons unknown persons, restrained
me and suddenly they started beating me with
fist & blows, at that time my son namely Alok
Sah (17 yrs) & my brother Ajay Sah passed from
there and they tried to save me but suddenly
said Ratan Sarkar took out the Coconut cutting
Daw (sharp cutting iron made weapon to cut raw
coconut) and attacked on my son Alok Sah,
and attempt to kill him, my said son received
grievous injury on his person & immediately
shifted to Arogya Niketan and treated there.

Sir, the above named alleged person and his
06 (six) associates are very desperate and dangerous
in nature, and they have threatened us for dire
consequences, if we will take any legal step
against them.
