Sir,

In producing herewith one arrested accused person namely Rabi Sarkar (54) S/O Lt. Gopal Ch Sarkar of Haider Para Bazar, Ward No. 39, PS Bhakti Nagar Dist. Jalpaiguri along with seized articles (i) 08 (eight) bottle of whisky styled as Royal Stag of 375 ml each, MRP Rs 490/- of each bottle (ii) 13 (Thirteen) bottle of whisky styled as Royal Challenge of 375 ml each, MRP Rs 500/- of each bottle (iii) 04 (Four) bottle of Whisky styled as Royal Challenge of 180 ml each, MRP Rs 241/- of each bottle (iv) 03 (Three) bottle of whisky styled as Imperial Blue of 180 ml each, MRP Rs 174/- of each bottle (v) 03 (Three) bottle of whisky styled as Bagpiper of 180 ml each, MRP Rs 139/- of each bottle (vi) 31 (Thirty one) bottle of Beer styled as kingfisher Strong of 650 ml each, MRP Rs. 130/- of each bottle (vii) 24 (Twenty four) bottle of Beer styled as Carls Bery premium of 650 ml of each bottle, MRP Rs 160/- of each bottle. Total value of seized articles Rs. 20,193/-

I, SI Rana Brahma of Panitanki TOP under Siliguri PS do hereby lodge a written complaint against the above noted accused person to the effect that today on 13.05.2021 at 21:25 hrs during my evening mobile van duty I received secret source information that the above noted accused person have open his shop at Panjabipara, besides Sevoke Road, PS Siliguri, Darjeeling and selling huge quantity of liquor illegally violating the order of West Bengal Govt duly promulgated in order No 79-CS/2020 dated- 12/04/2020 and Govt of West Bengal vide notification no. 347-I.S.S/2M-24/2020 dated-03/06/2020 and Govt of West Bengal order no. 715-Home (Cons) / RIM (Cons)-92/2021 dated-17/04/2021 and Chief Secretary, Govt. of West Bengal memo no. 486-CS/2021 dated-24/04/2021. Accordingly informed to O.C Panitanki TOP and thereafter as per his direction I along with, ASI Kheila Murmu, C/233 Nagen Ch Barman CV/377 Dinesh Roy, proceed to Panjabipara to work out the information. On arrival at Panjabipara besides Sevoke Road, PS Siliguri, Dist. Darjeeling at 21:35 hrs being pointed out by the source, found that above noted person stock huge quantity of various brand of liquor, beer etc, and selling the same to gain profit break-out of pandemic COVID-19 throughout the State. Over that, he had made some gathering by opening the shop violating the Government order. Accordingly I intercepted the said accused person with above noted articles in presence of witnesses. On interrogation the above noted accused person failed to produce any documents in support of the same and stated that he sale the same to the local public at Sevoke Road adjacent area illegally with a view to earn huge money for his lively hood. Accordingly, I seized above noted articles SL. No. 1 to 7 under proper seizure list and labeled the same in presence of witnesses and duly sign by them and by the accused person. The seizure was made between 21.45 hrs to 22.15 hrs.

As the above noted accused person violated the order of the Govt. of West Bengal as mentioned above intentionally and refused to comply with the Govt. order duly promulgated in view of break-out of pandemic COVID-19 throughout the State and sale liquor illegally. Over that, some of the local people were also annoyed with the accused person by such an act Hence I arrested the above noted accused persons U/S 41 Cr. P. C.

Hence, under the above fact and circumstances I pray that a specific Case may kindly be initiated against the above accused person namely Parbinder Singh (55) S/O Lt. Joginder Singh of Panjabi Para, Bhagat Singh Sarani, Ward No. 13, PS Siliuri, Dist. Darjeeling under proper section of Law and to arrange for its investigation.
