Sir,

In producing herewith four (04) arrested accused persons who disclosed their name & identity as (1) Raj Kishore Sah [31 yrs] S/O- Kapil Sah, (2) Suraj Sah [21 yrs] S/O- Satya Narayan Sah both of Durganagar near Isckon Mandir, Ward No- 40, PS- Bhaktinagar, Dist- Jalpaiguri, (3) Badal Chowdhury [40 yrs] S/O- Lt. Swapan Chowdhury of Tikiapara near Sagar Hotel, Ward No- 28, PS- Siliguri, Dist- Darjeeling & (4) Mintu Mandal [32 yrs] S/O- Sunil Mandal of Niranjn Nagar Colony near Kalibari Hospital, Khudiram Sarani, Ward No- 36, PS- Bhaktinagar, Dist- Jalpaiguri. I, SI Swadesh Saha of Siliguri PS/ SPC do hereby lodge this complaint to the effect that, on 14.05.2021 at 12.05 hrs during my Speacial mobile van duty, myself along with my accompanied force had been to Mahabirsthan area, Siliguri, found the above noted persons were gathered there without wearing mask on their face, without maintaining social distancing and without any proper reason.

On being asked, the above noted persons stated before me that, they were well aware of the present pandemic situation and they supposed to remain in home and not to come out without wearing mask on their face.

Hence, they violated the order for combating the spread of COVID-19 as per order of Govt. of West Bengal vide order no-79-CS/2020 dated 12.04.2020, notification no- 347-I.S.S/2M-24/2020 dated 03.06.2020, memo no- 486-CS/2021 dated 24.04.2021 and memo no- 629-ISS/2M-22/2020 dated 05.05.2021 in view of break-out of pandemic COVID-19 throughout the country as well as State. Accordingly, I arrested them u/s- 41 Cr.P.C in c/w the case.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
