Sir,

In producing herewith 04 (Four) arrested accused persons who disclosed their identity as (i) Bijay Kumar Sah-23yrs s/o Lt Dhrup Sah of Naya bazaar, Near Satyam Hotel, Khalpara, PS Siliguri Dist Darjeeling (ii) Jitendar Patel-26yrs s/o Lt Samant Singha of Chanoau, PO Bhankua PS Ujhani Dist Budaun UP at present C/o Pratik Agarwal of Naya bazaar near SBI Khalpara, PS Siliguri Dist Darjeeling (iii) Gunjan Paswan-26yrs s/o Khaltu Paswan of Jabravita, Near FCI Gate PS NJP Dist Jalpaiguri and (iv) Fulen Paswan-32yrs s/o Lt Sarjug Paswan of Rana busty, Near Gandhi Memorial Hindi Vidyalaya, ward no-18, PS Siliguri Dist Darjeeling along with all connecting paper.

I, SI. Srimanta Chatterjee of Khalpara TOP under Siliguri PS, SPC do hereby lodge complaint against the above noted arrested persons, to the effect that while on performing Special mobile van duty myself along with officer and force had been to Mahabirsthan, near Rail Gate, Siliguri at about 13.00hrs (Khalpara TOP GDE No- 431 dated 14.05.21) and found that the above noted persons had made unnecessary gathering at the public places without wearing mask. On being asked the above noted persons stated that they were well aware of the COVID-19 pandemic situation and disobeyed the Govt guidelines without any valid reason.

Hence all of them violated the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no -486-CS/2021 dated 24.04.21 arising out of order No- 79-CS/2020 dated 12.04.2020, & order No-629-1SS/2M-22/2020 dated 05.05.21 wearing of facial mask has been made mandatory in public places in the current pandemic disaster situation and to prevent spread of COVID-19. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break- out of Pandemic COVID- 19 throughout the Country. Accordingly I arrested them after issuing proper arrest memo and maintaining health protocols ensure their safety and security.

So, I therefore request you for starting a specific case under proper section of law against the above noted arrested accused persons and arranged proper investigation of the case.
