In producing herewith three (03) arrested accused persons who disclosed their name & identity as (1) Tapash Saha [62 yrs] S/O- Lt. Jatindra Saha of Sitalapara, Ward No-31, PS- NJP, Dist- Jalpaiguri, (2) Ayan Sasa [23 yrs] S/O- Amal Saha of Shaktigarh, Road No- 4 near Pathagar Club, Ward no- 31, PS- NJP, Dist- Jalpaiguri & (3) Arbind Prasad [24 yrs] S/O- Narayan Prasad of Natunpara, Ramghat, Ward No- 5, PS- Siliguri, Dist- Darjeeling. I, SI Uday Chakraborty of Siliguri PS/ SPC do hereby lodge this complaint to the effect that, on 15.05.2021 at 20.45 hrs during my Spl. mobile van duty, myself along with my accompanied force had been to Jalpaimore area, under Siliguri PS, found the above noted persons was in their shops and selling non essential items from their shops. Thereby making unnecessary gathering at their shops.

On being asked, the above noted persons stated before me that, they were well aware of the present pandemic situation and they supposed to remain in home and not to come out without wearing mask on their face.

Hence, they violated the order for combating the spread of COVID-19 as per order of Govt. of West Bengal vide order no-79-CS/2020 dated 12.04.2020, notification no- 347-I.S.S/2M-24/2020 dated 03.06.2020, memo no- 486-CS/2021 dated 24.04.2021 and memo no- 629-ISS/2M-22/2020 dated 05.05.2021 in view of break-out of pandemic COVID-19 throughout the country as well as State. Accordingly, I arrested them u/s- 41 Cr.P.C in c/w the case.


