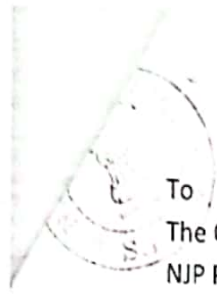

Sub: Written Complaint

Sir,

With due respect I, ASI Rabi Tamang Of Ambari-Falakata OP would lodge written complaint to the effect that on 11.05.21 at about 18.30 hrs while performing mobile van patrolling duty vide Ambari OP Misc. C.C. No. 1010/21 dt. 11.05.21, I had been to Bandhunagar, N.H. 31D road after receiving information about RTA and came to know that one Siliguri bound Pick Van, white in colour, bearing registration no. WB-71B/7303 has dashed one Motorcycle from the back side bearing Registration No. WB-74-AR/4637, Pulsar, black in colour while crossing the road (N.H. 31D), resulting which three persons namely (i) Allauddin Md. (32) S/o Majarul Haque (ii) Sahajahan Md. (30) S/o Hossain MD. and (iii) Ranjit Ali (25) S/o Lt. Sarifuddin Md. all Of resident of Sitaguri, P.O-Mahanvita, Ps-NJP, Dist-Jalpaiguri received severe injury on their persons and immediately shifted to Hospital by local people. On 12.05.2021 it came to know that one of the injured person namely Sahajahan Md. (30) S/o Hossain MD. of Sitaguri, P.O-Mahanvita, Ps-NJP, Dist-Jalpaiguri has been discharged from the Maharaja Hospital, Fulbari after giving First-Aid on the same day on 11.05.21 but today, on 12.05.21 morning he has been passed away at his residential house.

Under the above facts and circumstances, I, therefore pray that a specific case may kindly be initiated and arrange for its investigation accordingly.
