Sir,

With due respect, I am producing herewith the accused person namely Krishna Das (25 yrs) S/O Ranjit Das of Vill- Tritiya Gheri Uttar, Ganeshpur, PS- Kakdwip, Dist.- South 24 Parganas under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. One Truck displaying number plate WB/19/K/2182.
2. 37 (Thirty seven) numbers of blue colour plastic container (Drum) each container (drum) containing 200 ltrs of Raw Spirit i.e. total 7,400 (Seven thousand) ltrs of Raw Spirit marked as Exhibit- A, B, C, D, E, F, G, H, I, J, K, L, M, N, O, P, Q, R, S, T, U, V, W, X, Y, Z, AA, BB, CC, DD, EE, FF, GG, HH, II, JJ & KK, from which 500 ml of Raw spirit taken from each container and marked as A-1, B-1, C-1, D-1, E-1, F-1, G-1, H-1, I-1, J-1, K-1, L-1, M-1, N-1, O-1, P-1, Q-1, R-1, S-1, T-1, U-1, V-1, W-1, X-1, Y-1, Z-1, AA-1, BB-1, CC-1, DD-1, EE-1, FF-1, GG-1, HH-1, II-1, JJ-1 & KK-1.

I beg to report that today i.e. on 14.05.21 at 14.35 hrs I received a secret source information that one truck displaying number plate WB/19/K/2182 loaded with huge quantity of raw spirit with a view to sale the same in Bihar for the purpose of preparing illicit I/D liquor. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 604 dated 14.05.21 and informed the fact to you. As per your kind direction and instruction myself along with force left for Fulbari Toll Plaza to work out the information in hand. On the way to the spot I called two independent witnesses namely (i) Soumya BiKash @ Bubai Ghosh S/O late Jyoti Prakash @ Mantu Ghosh of Purba Dhaltala, PS- NJP, Dist.- Jalpaiguri and (ii) Sukamal Sengupta S/O late Subir Sengupta of Shaktigarh Road No-3, PS- NJP, Dist.- Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them to accompany with us in whole process during search and seizure. At about 14.55 hrs we arrived at Fulbari toll Plaza and waiting for the said truck. At about 15.05 hrs we found that the said truck was coming from Jalpaiguri side. We stopped the said vehicle at Fulbari Toll Plaza and found the above noted person boarded in the driving seat of the said vehicle. On being asked he disclosed his name and address as noted above and also disclosed that he is the driver of the said vehicle. During interrogation he disclosed that the vehicle is loaded with 37 number of container each container containing 200 ltrs of Raw Spirit. On searched we found that total 37 numbers of blue colour plastic container (Drum) each container (drum) containing 200 ltrs of Raw Spirit. During interrogation he stated that he loaded the said raw spirit at Barpeta, Assam and was proceeding towards Dalkhola, Bihar. During further interrogation he disclosed that he along with others 3/4 persons are doing such type of business since long for their wrongful gain. On demand he failed to produce any documents in respect of 7400 ltrs of raw spirit in 37 numbers of blue colour container (Drum) loaded in the said vehicle. He also failed to produce any documents in respect of vehicle having registration number WB/19/K/2182. On being further asked the above noted accused person stated that the said raw spirit is using for manufacturing of illegal ID liquor in Bihar. There was sufficient reason to believe that the said vehicle as well as the raw spirit are stolen one and the accused person are carrying stolen raw spirit from Assam to Bihar for their wrongful gain. Accordingly, I arrested him under proper memo of arrest and observing all the formalities of arrest and seized the above noted vehicle (truck) having registration number WB/19/K/2182 loaded with 37 (Thirty seven) numbers of blue colour plastic container (Drum) each container (drum) containing 200 ltrs of Raw Spirit i.e. total 7,400 (Seven thousand four hundred) ltrs of Raw Spirit under proper seizure list. The process of search, seizure and arrest made in between 15.15 hrs to 16.25 hrs.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the above noted arrested accused person namely Krishna Das (25 yrs) S/O Ranjit Das of Vill- Tritiya Gheri Uttar, Ganeshpur, PS- Kakdwip, dist.- South 24 Parganas and 3/4 others unknown persons and arrange for its investigation.
