Jahangir (31 yrs) S/O Late Ainul Mia of East Dhantala , PS- NJP, Dist- Jalpaiguri (2) Suresh Roy (42 yrs) S/O Late Swapan Roy of Srinagar Colony ,PS- NJP, Dist- Jalpaiguri (3) Karan Paswan (19 yrs) S/O Late Suresh Paswan of Barivasha , Bansbari PS- NJP, Dist- Jalpaiguri.

I, ASI Bhai Chandra Tamang of New Jalpaiguri Police Station, SPC do here by lodge this written complaint against the above noted persons to the effect that while on performing evening mobile Van duty in c/w NJP GDE No.704 dt. 16.05.2021 and MCC no.1259/21 dt. 16.05.2021, I, along with forces had been to Fulbari Bazar, in between 18:05 hrs to 18:25 hrs. and found that the above noted persons are gathered there without any reason and found them without wearing mask. There by making unnecessary gathering at Fulbari Bazar. On being asked the above noted persons stated before me that they were well aware of Govt. order regarding pandemic situation of Covid-19 and wearing of facial mask has been mandatory in public places in the current pandemic disaster situation.

They all are violated the order of Govt. of West Bengal vide Memo No. 486-CS/2021 dt. 24.04.2021. Hence, I arrested them in c/w the case under proper memo of arrest in between 18:05 hrs to 18:25 hrs. duly signed by them in presence of witnesses inform the ground of arrest.

Now I request you for starting a specific case U/S 188/269/270 IPC r/w sec 51 (b) of disaster Management Act.2005 against the above noted accused persons and arrange proper investigation of the case.
