Order in c/w Covid-19 pandemic as declared by the State Govt by the State Government vide No. 647-ISS/2M-22/2020, dated - 15.05.2020 disease due, Accordingly, I warned them but they did not pay heed any words and my lawful instruction as such, I arrested them observing all sorts of arrest rules.

Therefore, I pray before your kind honour that a specific case may kindly be started against the accused persons namely (i) Prafulya Roy (41), S/O Lt. Nagen Roy of Rabindra Sarani, P.S - MTG, Dist - DJG, (ii) Somoran Sarkar (50), S/O Lt. Dhaneswat Sarkar of Patiramjote, P.S - Matigara, Dist - DJG, (iii) Dhiraj Tiwari, S/O Lt. Baban Tiwari of Shivnagar, P.S - Matigara, Dist - Darjeeling under proper section of law and arrange for its investigation.
