In producing herewith the seized articles viz:-

- (i) 02(two) pieces partially loaded Indane gas cylinder (big domestic)
- (ii) 01(One) piece empty Indane gas cylinder (domestic big)
- (iii) 04 (four) pieces empty gas cylinder (small)
- (iv) 01 (one) piece gas refilling nozzle.
- (v) 01 (one) piece gas rubber pipe.

seized from the shop styled as "Deepa gas house" located at Sushrata Nagar, Medical more Ranidanga Road PS Matigara Dist- Darjeeling under proper seizure list with labelled in presence of local witnesses

I SI Pradip Chakraborty of Enforcement Branch, Siliguri Police Commissionerate do hereby lodge the written complaint against the accused person namely Suraj Soni (29 yrs.) S/O Kiran Kumar Prasad of Matigara Falaibhaktari, PS- Matigara, Dist- Darjeeling to the effect that on 17/05/2021 at about 08:05 hrs as per source information that the above noted accused person is illegally storing, refilling and selling Domestic LPG cylinders i.e. Indane, HP etc., in his shop for the purpose of refilling and selling in open market without any valid license or documents for his wrongful gain. Accordingly I inform the matter to the superior. As per direction of superior I, along with SI Goutam Kundu, ASI Prasanta Bardhan, ASI Ashok Biswas, CI/424 Manik Roy of EB SPC vide EB SPC M.C.C No 67/21 dt.17.05.2021 with Matigara PS van officer PSI Avhishek Theong, C /809 M.T Sherpa of Matigara PS, had been to Medical more Ranidanga Road PS- Matigara, Dist- Darjeeling to work out the information, this refers to Matigara PS GDE No 719/21 Dated 17/05/2021 at 09:05 hrs. At about 09:15 hrs we reached at Medical more Ranidanga Road PS- Matigara, Dist- Darjeeling, I contacted with source and being shown and identified by the source I along with force conducted raid in the shop styled as "Deepa gas house" is running by Suraj Soni. On seeing the Police party the shop owner namely Suraj Soni fled away from the shop for avoid police arrest.

I managed a independent 02(Two) witnesses namely 1. Samir Biswas S/O Pankaj Biswas of Sushrata Nagar, Medical more Ranidanga Road, PS- Matigara, Dist- Darjeeling and 2. Amit Ghosh S/O Nimai Ch Ghosh of Sushrata Nagar, Medical more Ranidanga Road, PS- Matigara, Dist- Darjeeling Nobody came that place and nobody produced any valid documents/ License in respect of above noted seized Gas cylinder. During local enquiry it could be learnt that the said shop is running by accused namely Suraj Soni. It is crystal clear that the absconding accused person namely Suraj Soni (29 yrs.) S/O Kiran Kumar Prasad of Matigara Falaibhaktari, PS- Matigara, Dist- Darjeeling is storing, refilling and selling the Domestic cylinders in his shop for his wrongful gain. As per local enquiry it came to light that he negligent conduct with respect to fire or combustible matter, any act so rashly or negligently as to endanger human life or to be likely to cause hurt or injury to person that bazaar area and no valid License/Permit of dealing/distribution/refilling LPG. Thus the above noted accused person violated the provision of law and West Bengal Cooking Gas(License and Control) order 1985 Act.

Accordingly I seized the above noted Domestic INDANE and Non-branded small Gas cylinders with Gas pipe and Nozzle under proper seizure list with labelled in presence of independent witness above noted U/S. 102 Cr.P.C. The seizure was made in between 09:25 hrs. to 09:45hrs.

Hence, I pray before you that a specific case U/S 285 IPC RW Sec. 7(1)(a)(b)(c) of EC Act 1955 may kindly be initiated against the accused person namely "Suraj Soni (29 yrs.) S/O Kiran Kumar Prasad of Matigara Falaibhaktari, PS- Matigara, Dist- Darjeeling" and arrange for its investigation.
