Sir,

In producing herewith one arrested accused person/lady namely (i) Idris Ali @ Manik (29) s/o Md Halim of Biswas Colony, PS Matigara, Dist. Darjeeling and (ii) Samina Begum (40) W/O Md. Jahar Ali of Biswas Colony, PS Matigara, Dist. Darjeeling (not verified) along with the following seized articles under seizure as per seizure list:

- i) One packet containing 12 Kg of "Ganja" wrapped with Yellow colour plastic and white colour cello-tape being kept inside a bag and marked as 'Exhibit-A'.
- ii) 100 grams of ganja extracted from exhibit 'A' for examination and marked as 'Exhibit A-1'
- iii) One packet containing 12 Kg of "Ganja" wrapped with Yellow colour plastic and Brown colour cello-tape being kept inside a bag and marked as 'Exhibit-B'.
- iv) 100 grams of ganja extracted from exhibit 'B' for examination and marked as 'Exhibit B-1'
- v) One Blue & Red colour hand bag written on it "adidas" in which seized articles SL no i) was kept.
- vi) One Olive & Red colour hand bag written on it "adidas" in which seized articles SL no iii) was kept.

I, SI Shekhar Adhikary of Matigara Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint against above noted persons to the effect that on 17/05/2021 at about 15:05 hrs received a specific source input that one person and a lady were standing at By pass more under PS Matigara with huge quantity of Ganja for delivering the same to their designed customers. The matter was diarized in Matigara PS GDE No. 733 Dt- 17.05.2021 and also informing the matter to the Officer-In- Charge, Matigara Police Station in written and being directed I along with ASI Subhendu Das, ASI Nitai Mandal, Const-1035 Santosh Rabidas, Const- 1008 Kanak Roy and Const- 986 Rajib Sarkar all belongs to Matigara Police Station left for By pass more under PS- Matigara by Govt vehicle to verify the veracity of the information vide Matigara PS M.C.C. NO 651 Dt. 17/05/2021.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

At the time of departure from Police Station I took envelope, white paper, sealing wax, gum, seal, Digital weighing machine (Certified by the weight and Metallurgy department) etc.

On way to By Pass More, I contacted two persons namely (i) Md. Khalilur Rahaman s/o Lt Md. Hassan of Tari Jote, PO. New Rongia, PS Matigara, Dist. Darjeeling 2) Sanu Chhetri s/o Lt. Chandra Bahadur Chhetri of Matigara Bazar PS Matigara, Dist. Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter we along with the independent witnesses reached at By Pass More, at 15:35 hrs and subsequently being pointed and shown by my reliable source apprehended above noted persons.

Thereafter, we disclosed our identity and the information in hand and stated them that they will be searched in person for the purpose. At this, they after disclosing their identity as noted above admitted that they have illegally possessed ganja in their possession for selling the same to their designed customers as per requirement. I then gave them option in writing whether they wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer. Then they agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused persons to search our Police Party as per provisions but, they did not search the police party.
