Sir,

In producing herewith one accused person namely Sadananda Das (28), S/O- Lt.- Robin Das of 2 No Jyoti Nagar, PS- Bhaktinagar, Dist.- Jalpaiguri in custody and the following articles under seizure along with seizure list (i) 10 Pieces of single use of disposable including needle marked as Exhibit- D, (ii) 23 (twenty three) pieces of Butrenothine Injection I.P. (LUPIGESIC) and marked as Exhibit-A, (iii) 02 (two) pieces of Butrenothine Injection I.P. (LUPIGESIC) taken from Exhibit-A' as sample and marked as Exhibit-A-1' (iv) 21 (twenty one) pieces of Promethazine, Hydrachloride Injection (PHEERGAM) and marked as Exhibit-B' (v) 02(two) pieces of Promethazine, Hydrachloride Injection (PHEERGAM) taken from exhibit-B as sample and marked as Exhibit- B-1', (vi) 17 (seventeen) pieces of Diazepam Injection (Diazalab) and marked as Exhibit-C, (vii) 02 (two) pieces of Diazepam Injection (Diazalab) taken from Exhibit-C' as sample and marked as Exhibit C-1'.

I AS.I Subandhu Das of Matigara PS, SPC do hereby lodged this complaint to the effect that on 17.05.2021 at about 15.25 hrs received an information from my secret source that one person possessing huge quantity of drugs in his possession without valid documents is proceeding towards Beldangi from Biswas Colony side under P.S- Matigara, SPC for the purpose of selling to young boys. Accordingly the information has been diarized vide Matigara PS SPC GDE No. 735 Dtd. 17.05.2021 and informed to O/C PS, SPC and as per his kind order myself along with ASI Nitai Mandal, Const-1035 Santosh Rabidas, Const- 1008 Kanak Roy and Const- 986 Rajib Sarkar left PS to verify the veracity of the information vide C.C No- 652/21 Dt. 17.05.2021. While myself along with party reached at the spot and as shown and identified by the source we found one person was standing with one red colour cotton carry bag. Seeing our team he tried to flee away from the spot but our team managed to detain him for interrogation. On being asked the detained person disclosed his name and address as noted above and also disclosed that he is possessing Drug inside the bag which he was carrying and possessing also obtained the same fraudulently for selling to young boys for his wrongful gain. Then I Called two disinterested witnesses namely (a) Dharmendar Chourishiya(30), S/O- Lt. Ramprabesh Chourishiya of Beldangi, Tumbajote, PS- Matigara, Dist- Darjeeling and (b) Suraj Roy(26), S/O- Umesh Roy of Beldangi, Tumbajote, PS- Matigara, Dist- Darjeeling, from that place. In presence of the cited witnesses search was conducted and above noted Drug were recovered from the possession of alleged person namely Sadananda Das and all the above noted articles have been seized and labeled in presence of above noted cited witnesses under proper seizure list and duly signed by the accused as well as witnesses and took into custody as alamt property. On interrogation and demand the accused person failed to produce any valid document or any valid licenses in support of his possession of huge quantity of stock of drugs. The accused Sadananda Das also confessed that he obtained the consignment of drugs with a view to sell/ distribute throughout Darjeeling, Sikkim and Tea Garden of Dooars area with the help of other confederates. Hence I took him into custody after obeying all the guidelines of Honorable Apex Court of India regarding arrest. The seizure was made in between 16.15 hrs to 17.05 hrs.

Hence it is prayed that a specific case may kindly be started against the accused namely Sadananda Das(28), S/O Lt.- Robin Das of 2no Jyoti/Nagar, PS- Bhaktinagar, Dist.- Jalpaiguri and others and arrange for its investigation.
