While our emergency vehicle staff went to attend the call they found that some of the electrical equipments has been damaged. Then our emergency vehicle staffs (Ranjit Sarkar-Driver, Swarup Sarkar-Skilled Labor, Uttam Singha-Unskilled Labor, Sanjit Roy-Unskilled Labor, Swapan Paul-Skilled Labor) attended the call and restored the power in the locality. But after that the mob surrounded our staffs near Chandmoni hospital line and kept on showing agitation. After that local Police station was informed and they went to the spot and rescued our staffs.
