Sir,

In producing herewith three (03) arrested accused persons who disclosed their name & identity as Smt. Tara Saha (30 yrs) W/O- Jayanta Saha of Ambari Border, PS- Phansidewa, Dist- Darjeeling, (ii) Payel Lama (37 yrs) D/O- Ajit Lama of Kalamjon, Susurata nagar, PS-Matigara, Dist- Darjeeling & (iii) Nikunja Behari Bhattacharjee (55 yrs) S/O- Lt. Narmada Charan Bhattacharjee of Santinagar, Dabgram, PS-Bhaktinagar, Dist-Jalpaiguri. I, SI Mihir Majumder of Siliguri PS/ SPC do hereby lodge this complaint to the effect that, on 17.05.2021 at 11.35 hrs during my mobile van duty, myself along with my accompanied force had been to Venus More area, under Siliguri PS, found the above noted persons were gathered there without wearing mask on their face, without maintaining social distancing and without any proper reason.

Hence, they violated the order for combating the spread of COVID-19 as per order of Govt. of West Bengal vide order no-79-CS/2020 dated 12.04.2020, notification no- 347-I.S.S/2M-24/2020 dated 03.06.2020, memo no- 486-CS/2021 dated 24.04.2021, memo no- 629-ISS/2M-22/2020 dated 05.05.2021 and order no- 647-ISS/2M-22/2020 dated 15.05.2021, in view of break-out of pandemic COVID-19 throughout the country as well as State. Accordingly, I arrested them u/s- 41 Cr.P.C after observing all rules and formalities in c/w the case.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested three (03) MLAs and 2/3 others and arranged proper investigation of the case.
