In producing herewith three (03) arrested accused persons who disclosed their name & identity as Smt. Hence, they violated the order for combating the spred of COVID-19 as per order of Govt. of West Bengal vide order no-79-CS/2020 dated 12.04.2020, notification no- 347-I.S.S/2M-24/2020 dated 03.06.2020, memo no- 486-CS/2021 dated 24.04.2021, memo no- 629-ISS/2M-22/2020 dated 05.05.2021 and order no- 647-ISS/2M-22/2020 dated 15.05.2021, in view of break-out of pandemic COVID-19 throughout the country as well as State. Accordingly, I arrested them u/s- 41 Cr.P.C after observing all rules and formalities in c/w the case.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested three (03) MLAs and 2/3 others and arranged proper investigation of the case.
