In producing herewith eight (08) arrested accused persons who disclosed their name & identity as (i) Parimal Barman (45 yrs) S/O- Lt. Nagendra Barman of Ghorabari, PS-NJP, Dist-Jalpaiguri, (ii) Samajit Sarkar (40 yrs) S/O- Lt. Labu Sarkar of vill & PO- Sufanpara, Ghoksadanga, PS-Ghoksadanga, Dist-Coochbehar A/P- Ambika Nagar, Nichpara, PS-NJP, Dist-Jalpaiguri, (iii) Sujan Ghosh (32yrs) S/O- Bhola Ghosh of Tilok Sadhu More, PS-Bhaktinagar, Dist-Jalpaiguri, (iv) Rahul Magar (20yrs) S/O- Bhim Magar of Ghoshpukur, Bonotutiya, PS- Phansidewa, Dist- Darjeeling, (v) Dipak Thapa (33yrs) S/O- Balbahadur Thapa of Kalamjote, Susratanagar, PS-Matigara, Dist-Darjeeling, (vi) Sanjoy Kr Agarwal (52yrs) S/O- Lt. I SI Uttam bagira of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons, to the effect that, on 17.05.2021 at 12.15 hrs during my R/T mobile duty, myself along with my accompanied force had been to Venus More, Siliguri and found the above noted persons were roaming without wearing mask on their face and without any proper reasons alongwith their vehicles bearing Reg No- Viz (i) E-rickshaw (TOTO) without TIN number, (ii) E-rickshaw (TOTO) without TIN number, (iii) Auto Ricksaw bearing Reg No. WB 73F/5687, (iv) One Alto 800 LXI Car bearing Reg No. WB 74AN/6246, (v) one grey colour Toyota Fortuner bearing Reg No. WB 74R/7599, (vi) one white colour Scorpio Micro vehicle bearing Reg No. RJ19VC/0577 (vii) One white colour Maruti Suzuki Wagner bearing Reg No- WB73C/9518.

On being asked, the above noted persons stated before me that, they were well aware of the lock down situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of India duly promulgated in order No. 40-3/2020-DM-1(A), Govt. of India Ministry of Home affairs dated 24.03.2020 & MHA (Internal Security Division) vide no- 11034/01/02022-IS-IV dated 27.04.2020 and Govt. of West Bengal order no- 134-Pr. Sec (Tr) dated 04.06.2020 & Order no- 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of India duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case U/Ss- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
