In producing herewith seven (07) arrested accused persons who disclosed their name & identity as (i) Mintu Roy (32 yrs) S/O- Nirmal Roy of Deshbandhupara, Pran Krishna Colony, Ward No-28, PS-Siliguri, Dist-Darjeeling, (ii) Raju Bhujel (38 yrs) S/O- Lt. Gopal Bhujel of NJP Rajaholi, Ward No-35, PS-NJP, Dist-Jalpaiguri, (iii) Prabir Kr Paul (36 yrs) S/O- Prakash Ch. Paul of Iskon Mandir Road, Gitalpara, Ward No-40, PS-Bhaktinagar, Dist-Jalpaiguri, (iv) Firoj Ali (30 yrs) S/O- Lt. Ali Ahmed of Subashpally, Lichubagan, Ward No-18, PS-Siliguri, Dist-Darjeeling, (v) Raju @ Babu Sarkar (30 yrs) S/O- Tapan Sarkar of Deshbandhupara, near Belabekary, Ward No-29, PS-Siliguri, Dist-Darjeeling, (vi) Rajesh Das (41yrs) S/O- Nandalal Das of NJP Gatebazar, PS-NJP, Dist-Jalpaiguri & (vii) Zahidul Rahaman (35 yrs) S/O- Mahaddin C/O- Bacchu Paul, Asraf Nagar, Ward No-40, PS-Bhaktinagar, Dist-Jalpaiguri. I SI Uday Chakroborty of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons, to the effect that, on 17.05.2021 at 13.55 hrs during my Spl. mobile duty, myself along with my accompanied force had been to Tikiapara area, under Siliguri PS and found the above noted persons were roaming without wearing mask on their face and without any proper reason alongwith their vehicles bearing nos- Viz (i) E-rickshaw (TOTO) bearing No- WB73/4646, (ii) E-rickshaw (TOTO) without TIN number, (iii) E-rickshaw (TOTO) without TIN number, (iv) One Bus bearing Reg No. WB73E/2649, (v) One E-rickshaw (TOTO) bearing No- WB73TC/0399, (vi) One E-rickshaw (TOTO) bearing No- WB73F/5139 & (vii) One E-rickshaw (TOTO) bearing No- WB73/2642.

On being asked, the above noted persons stated before me that, they were well aware of the lock down situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of India duly promulgated in order No. 40-3/2020-DM-1(A), Govt. of India Ministry of Home affairs dated 24.03.2020 & MHA (Internal Security Division) vide no- 11034/01/02022-IS-IV dated 27.04.2020 and Govt. of West Bengal order no- 134-Pr. Sec (Tr) dated 04.06.2020 & Order no- 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of India duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C after observing all rules and formalities in c/w the case.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged for proper investigation of the case.
