Hence, they violated the order of the Govt. of West Bengal duly promulgated in order No. 647-ISS/2M-22/2020 dated 15.05.2021 The above noted person has intentionally refused to comply with the Govt. order duly promulgated in view of break-out of pandemic COVID-19 throughout the State. Accordingly, Larrested the above noted accused persons U/S 41 Cr. F. C.
