I, SI Prabhash Saha of Panitanki Town Out Post, PS- Siliguri, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that on 17.05.2021 at about 19:55 hrs. while performing Naka duty at Panitanki More area and found the above noted arrested persons were moving here and there without using face mask. On being asked they disclosed their name as (1) Rajib Kumar (34) S/O Lt. Sadhya Prasad, of Vill + PO- Jayatpur, PS- Sariya, Dist- Mujaffarpur (Bihar) A/P Mahabiristan Alupatty, PS- Siliguri, Dist- Darjeeling (2) Biplab Saha (48) S/O Lt. Manoranjon Saha of Raja Rammohan Roy Road, Hakimpara, PS- Siliguri, Dist- Darjeeling (3) Ujjal Chaki (48) S/O Lt. Sachindra Nath Chaki of Mahanandapara, Ward No. 06, PS- Siliguri, Dist- Darjeeling (4) Anish Gupta (35) S/O Bijoy Gupta of South Colony, Goyala Basti, PS- NJP, Dist- Jalpaiguri (5) Ramesh Orawn (27) S/O Lt. Metlu Orawn of Kurti Tea state, PS- Nagrakata, Dist- Jalpaiguri, (6) Nayan Roy (20) S/O Dinesh Roy of Vill- Santi Nagar, PS- Naxalbari, Dist- Darjeeling (7) Sk. Jamal (32) S/O Sk. On interrogation, it could be learnt that they had no any reason to move here and there without using facial mask during Pandemic disaster situation and unlock period. Over that some of the local peoples were also annoyed with the accused persons by such an act. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving without facial mask & valid reason. They negligently and malignantly move to spread infection of any decease dangerous to life during Pandemic disaster situation and unlock period.

Hence, they violated the order of the Govt. of West Bengal duly promulgated in order No. 647-ISS/2M-22/2020 dated 15.05.2021 The above noted person has intentionally refused to comply with the Govt. order duly promulgated in view of break-out of pandemic COVID-19 throughout the State. Accordingly, I arrested the above noted accused persons U/S 41 Cr. P. C.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Rajib Kumar (34) S/O Lt. Sachindra Nath Chaki of Mahanandapara, Ward No. 06, PS- Siliguri, Dist- Darjeeling (4) Anish Gupta (35) S/O Bijoy Gupta of South Colony, Goyala Basti, PS- NJP, Dist- Jalpaiguri (5) Ramesh Orawn (27) S/O Lt.
