In producing herewith six (06) arrested accused persons who disclosed their name & identity as (i) Sariful Haque (24 yrs) S/O- Md. Mojibuddin of Iskon Mandir Road, Ashraf Nagar, PS-Bhaktinagar, Dist-Jalpaiguri, (ii) Shambhu Sahani (48 yrs) S/O- Lt. Ram Chandra Sahani of Salunagar Bhabesh Ch Colony, PS-Bhaktinagar, Dist-Jalpaiguri, (iii) Dipankar Sarkar (39 yrs) S/O- Dilip Sarkar of Sukanta nagar, near Auto Stand, PS-Bhaktinagar, Dist-Jalpaiguri & (iv) Sujit Prosad (46 yrs) S/O- Naresh Prosad of South Colony, near NJP Rly Station, PS-NJP, Dist-Jalpaiguri, (v) Aminul Islam (22 yrs) S/O- Md. Kabiruddin of Dhanirhat, Daspara, PS-Chopra, Dist-Uttar Dinajpur & (vi) Sanjan Bhadra (38 yrs) S/O- Lt. Anil Kumar Bhadra of Surya Sen Colony, Block-C, Ward No-34, PS-NJP, Dist-Jalpaiguri and their six vehicles bearing Reg Nos. Viz (i) Toto Rickshaw van without number plat, (ii) one scooty bearing Reg No- WB 74BB/0635, (iii) Toto Rickshaw van without number plat, (iv) Toto Rickshaw van without number plat, (v) Toto Rickshaw van without number plat, (vi) Toto Rickshaw van ash colour without number plat, I SI Subhankar Ghosh of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons, to the effect that, on 18.05.2021 at 12.15 hrs during my Spl. Van duty at Thana More are, Siliguri, found the above noted persons were moving alongwith their vehicles without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the lock down situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of India duly promulgated in order No. 40-3/2020-DM-1(A), Govt. of India Ministry of Home affairs dated 24.03.2020 & MHA (Internal Security Division) vide no- 11034/01/02022-IS-IV dated 27.04.2020 and Govt. of West Bengal order no- 134-Pr. Sec (Tr) dated 04.06.2020 & Order no- 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of India duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
