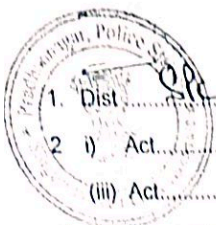

They abused them saying sala Boka choda Adivasi, kalo Masurh, chhotto Jal kothakar, Madar choda Baccha gulo etc. They (Bagan Manager and party) also pushed them using their muscle power and in the process the lady workers who had been present there were also manhandled by the above person thus outraging their modesty.

So I am requesting you please take strict action and against them otherwise we will fail to control the situation and Administration have to take responsibility for it.
