Sir,

I, SI Samik Paul presently posted at Pradhannagar Police Station, SPC would like to lodge this written complaint against one (01) arrested lady accused person named Sona Devi (65), W/O- Lt Nathuni Mishra of Mallaguri, Ratanlal busty, W/No-45, P.S.- Pradhan nagar, Dist- Darjeeling who had been arrested for contravening the norms of NDPS Act and also produced the following seized articles under seizure as per seizure list:

- i) 5.3 kgs Ganja inside of yellow & green color Plastic bosta printed as Shantibhog Minikit rice, which marked as Exhibit-A,
- ii) 100 gms of Ganja Marked as Exhibit A-1 as sample taken from Exhibit -A

In this regard I beg to state that today i.e. on 18.05.2021 at about 14.15 hrs myself received a secret source information that one lady namely Sona Devi stocks huge quantity of Ganja in her possession at her house and selling the same to her local customers. Wasting no time I diarized the information vide PDN PS GDE NO. 919 Dt. 18.05.21 and consequently informed of the tip off to you and as per your kind instruction. myself along with SI Binup Mahato, ASI Debasish Das, ASI Ratan Pradhan, ASI Ashit Singha, LC/744 Sarda Sarki, LC/469 Pramila Chettri, CV-131 Ranjan Sharma, CV-223 Swapan Chhetri, CV-128 Ajay kumar Sahani all of Pradhannagar PS, SPC left for Ratanlal busty under Pradhannagar P.S. area by Govt. vehicle No WB73 to verify the veracity of the information vide Pradhannagar P.S. CC No 1289/21, and Pradhan nagar P.S. GDE. No. 920, Dt- 18.05.2021 at 14.25 hrs along with the IO Kit including Weighing machine etc. At about 14.35 hrs we arrived at Ratanlal busty and called two independent witnesses namely 1) Rahul Das (20), S/O- Laxmi Das of Mallaguri Tea Auction road, P.S. Pradhan nagar, Dist- Darjeeling, 2) Bachan Sahani (42), S/O- Lt Jogi Sahani of Ratanlal busty, W/No-1, P.S.- Pradhan nagar, Dist- Darjeeling and disclosed our identity and informed them about the information in hand and requested them to accompany us in the whole process of search and seizure if necessary. As identified by the source we had been to the house of Sona Devi. Thereafter I gave her the option to be searched before a Magistrate or a Gazetted Officer upon which he agreed to be searched before a gazette officer and I also gave her a written information in this regard and read it out the same and he give consent verbally.

Consequently I contacted to the Sri Subasisi Chaki ,I/C Pradhannagar PS SPC for come to the spot and supervise the entire process of search and seizure. Sri Subasisi Chaki ,I/C PS SPC arrived at the spot at 15.25 hrs, thereafter the process of the search was started. Before conducting search self search of me and Sri Subasisi Chaki ,I/C Pradhannagar PS SPC had been conducted by the detained person and a memo had been given to him to the effect that and he could not find any other offending things except arms and IO kit and weigh machine..

On searched from the yellow & green color Plastic bosta I recovered huge quantity ganja. Thereafter I started weighting the Ganja containing with a weighing machine kept with us for the purpose of weighing and on weighing 5.3 kgs Ganja recovered inside of the said bosta printed as Shantibhog Minikit rice from the house of Sona Devi (65), W/O- Lt Nathuni Mishra of Mallaguri, Ratanlal busty, W/No-45, P.S.- Pradhan nagar, Dist- Darjeeling.

Thereafter I seized the recovered 5.3 kgs of Ganja in between 15.30 hrs to 16.15 hrs from the Possession of lady accused person namely Sona Devi (65), W/O- Lt Nathuni Mishra of Mallaguri, Ratanlal busty, W/No-45, P.S.- Pradhan nagar, Dist- Darjeeling by preparing a seizure list duly signed by the independent witnesses & lady accused person. In the seizure list I obtained the signature of Sri Subasish Chaki ,I/C Pradhannagar PS SPC and also put my signature i) 5.3 kgs Ganja inside of yellow & green color Plastic bosta printed as Shantibhog Minikit rice, which marked as Exhibit-A, ii) 100 gms of Ganja Marked as Exhibit A-1 as sample taken from Exhibit -A taken before of the Detained person, independent witnesses, I/C Pradhannagar PS, and put signature of all persons including me.

Consequently the apprehended above noted person had been arrested by me at 16.20 hrs by issuing a proper Arrest Memo for contravening the norms of NDPS Act and returned back to P.S. at 17.05 hrs vide Pradhan nagar P.S. GDE No 923, Dated 18.05.2021.

In the above circumstance, I pray before you to take the seized articles and sample & lady Accused Sona Devi (65), W/O- Lt Nathuni Mishra of Mallaguri, Ratanlal busty, W/No-45, P.S.- Pradhan nagar, Dist- Darjeeling started a specific case against the arrested accused person under appropriate section of law and arrange for its investigation
