Respected Sir,

I, Rehana Khatoon, Wife of Md. Yunus, of Sastri Nagar, Opposite side of Iskon Mandir, Ward No.41 of S.M.C. P.O. Sevoke road, P.S. Bhakti Nagar, Dist- Jalpaiguri, would like to report you the following facts:-

1. That my marriage was solemnized with Md. Yunus 27 years ago, and at the time of marriage my father had given dowry to my in-laws as per their demand.
2. That my mother in-law Sadikan Begam, sister in-law Samina Khatoon, elder brother in-law Md. Nasrul, younger brother in-law Md. Ibrahim have been continuously torturing me to bring cash from my father's house and telling that if I do not fulfill their demand then they would not allow me my husband my children to live in my in-laws house.
3. That several times salishi meetings were held but even after that their torture upon us has not been stopped.
4. That it is to be mentioned here that previously also my aforesaid in-laws had mercilessly beaten me and outrage my modesty and a specific case was started against them at Bhaktinagar Police Station and at that time they by enticing me and assuring me that such incident would not occur in torture made me to compromise the aforesaid case but after such compromise their torture upon me again started.
5. That now in order to drove me and my family members out from my in-laws house. My aforesaid in-laws have been continuously torturing me and they have been continuously abusing me and my husband and children whole day long and not allow me to fetch water from the well/hand pump, throw garbage in my room and even to drive us out cut the electric connection of our room and now we have been passing our days in dark.
6. That even after that when we did not leave our room then 7 days ago my brother in-law and sister in-law by a Khunti broke down the outer wall of

our room and when we tried to restrain them then they started abusing me and when I started crying for help they went away from there.

7. That on 16.5.2021 at about 9 p.m. again my aforesaid in laws, along with one Santosh Bhagat, Son of not known to me of same address (with whom my in-laws have made agreement for sale of my said portion of land in which my room is situated) came armed with Iron rod (Khunti) for demolishing my room and started hitting on the wall to break down it and told that if we do not vacate our said room then they will demolish the same and started throwing all our articles out of our room. Seeing this I rushed to restrain them from demolishing our room and at that time they started assaulting me and by fists and blows and tore my wearing apparels and said Santosh Bhagat came with Khunti to hit me with it and when I caught hold said khunti from stopping him to hit me at that time he caught hold my hands and my in-laws started to strangulate me with intent to murder me. In the meanwhile my children and one para people gathered there and saved me from their clutch and they left me and threatened that we have one day time if we do not vacate our said room then they would set fire in our room in the night and burn us along with our room and at that time no one could save us.

Due to their such assault I received injury on my person and I went at Siliguri S.D. Hospital for treatment where I was told that no doctor is available so to come on another day and thereafter on 17.05.2021 again I went at Hospital and was treated there.

I, therefore, requested you to kindly take necessary legal action in the aforesaid matter against the aforesaid culprits.
