In producing herewith one accused person namely Bishal Rai (31) S/O- Binod Rai of Sashttrinagar, behind Gul Mohor Appartment, w/n-41,PS- Bhaktinagar, Dist.- Jalpaiguri along with seized articles i.e. (1) 06(Six) bottles of Tuborg Strong Beer (each bottle containing 650ML) (2) 07(Seven) bottles of Tuborg Premium Beer (each bottle containing 650ML) 3. 25(Twenty Five) Bottle of 60UP PET Himalayan Gold Country Spirit (each bottle containing 600ML) 4. 07(Seven) Bottle of 60UP PET Himalayan Gold Country Spirit (each bottle containing 300ML) 5. 07(Seven) Bottle of 60UP PET Boss Country Spirit (each bottle containing 300ML) 6. 09(Nine) Pouch of Officers Choice Deluxe Whisky (each Pouch containing 180ML) 7. 12(Twelve) Pouch of Mc Dowells No-1 Celebration Matured xxx RUM(each Pouch containing 180ML) 8. 06(Six) Pouch of Mc Dowells No-1 Celebration Matured xxx RUM(each Pouch containing 190ML).

I, SI Sibdhan Karmakar of Bhaktinagar P.S. under Siliguri Police Commissionerate do here by lodged a written complaint against Bishal Rai (31) S/O- Binod Rai of Sashttrinagar, behind Gul Mohor Appartment, w/n-41,PS- Bhaktinagar, Dist.- Jalpaiguri to the effect that today on 19.05.2021 while I was performing Special raid duty as per order of my superior vide Bhaktinagar PS GDE NO-952 date 19.05.2021, received a specific input from the source at 22.50 hrs. that the above noted person has kept huge numbers of illicit liquor in his House at Sashttrinagar, behind Gul Mohor Appartment, w/n-41 under Bhaktinagar P.S. in order to clandestinely dispose the same. Accordingly the fact is informed to I/C Bhaktinagar PS and as per his direction I along with ASI Biswajit Saha ,CV. 614 Sumit Roy ,CV-619 Dharmendra Roy left for Sashttrinagar, behind Gul Mohor Appartment, w/n-41 under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by source cordoned the House where he kept illegal alcohol. On arriving there found the above noted person who disclosed his identity as noted above who kept the same at his shop in conceal position. On searching found huge numbers of above noted seized Articles. On being interrogation he could not produce any valid documents in respect of the said illicit liquor. He also stated that he is doing this liquor business since last 04 months for wrongful gain. Accordingly I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 23.05 hrs to 23.35 hrs. On being asked he stated that he kept the same with a view to sale and supply at Sashttrinagar area without any valid documents. As he has violated the norms of Bengal Excise Act as such I arrested him after observing all sorts rules for selling the said country made spirit and beer without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accd. Bishal Rai (31) S/O- Binod Rai of Sashttrinagar, behind Gul Mohor Appartment, w/n-41,PS- Bhaktinagar, Dist.- Jalpaiguri as per proper section of law.
