S.I. Subir Chowdhury of Matigara P.S Siliguri Police Commissionerate do hereby lodged a written complaint against above noted persons (i) Prasenjit Singha (25), S/O Sarat Singha of B.ED College, Shivmandir, P.S - Matigara, Dist - Darjeeling and (ii) Abhijit Roy (27), S/O Hiten Roy of B.ED College Para, Shivmandir, P.S - Matigara, Dist - Darjeeling to the effect that today on 19.05.2021 at 06:00 hrs onwards myself along with force while performing lock down duty at Shivmandir under Matigara P.S area at that time it was found that above noted accused persons were loitering at above noted area with were any face mask with any rhyme and reason which is amounting to Non-Compliance of Govt. Order in c/w Covid-19 pandemic as declared by the State Govt by the State Government vide No. 647-ISS/2M-22/2020, dated - 15.05.2020. Accordingly, I warned them but they did not pay heed any words and my lawful instruction as such, I arrested them observing all sorts of arrest rules.

Therefore, I pray before your kind honour that a specific case may kindly be started against the accused persons namely (i) Prasenjit Singha (25), S/O Sarat Singha of B.ED College, Shivmandir, P.S - Matigara, Dist - Darjeeling and (ii) Abhijit Roy (27), S/O Hiten Roy of B.ED College Para, Shivmandir, P.S - Matigara, Dist - Darjeeling under proper section of law and arrange for its investigation.
