Sir,

In producing herewith the accused person namely Bijan Das (26), S/O- Ashu Das of Champasari more, Anandamoyee Colony, PS Pradhannagar, Dist- Darjeeling in custody and the following property under seizure along with seizure list-

- (i) 71 (Seventy one) strips of "SIMPLEX C+" capsules, (each capsules contains Tramadol Hydrochloride 50, Dicylomine Hydrochloride 10 mg, Chlorpheniramine Maleate 4 mg), each strips containing 08 capsules and marked as **Exhibit-A**, (Total capsules 568) which was kept in a white colour carry bag.
- (ii) 01 (One) stripe of "SIMPLEX C+" capsule taken as sample, marked as **Exhibit-A1**, from the Exhibit-A.

I, SI Binup Mahato of Pradhannagar Police station, SPC do hereby lodged this complaint to the effect that on 18.05.2021 at about 21.35 hrs received an information from my secret source that a person is roaming at Champasari more near State Guest house with huge quantity of drugs in his possession for the purpose of selling/distributing at local area. Accordingly the information diarised vide PDN P.S. GDE No-931 Dt-18.05.2021 and informed to the I/C Pradhannagar P.S., SPC and as per your kind instruction myself along with, ASI Debasish Das, ASI Ashit Singha, ASI Ratan Pradhan, CV/131 Ranjan Sharma, CV/646 Baban Das all of Pradhannagar P.S., SPC left for that area to verify the veracity of information at 21.45 hrs vide Pradhan nagar P.S. GDE No 932, Dated 18.05.2021. While myself along with party reached at the spot at Champasari more, near State Guest house and we took two disinterested witnesses namely 1) Anil Kumar (30), S/O- Krishna Prasad of Gurung busty, Nivedita Road, P.S. Pradhan nagar, Dist- Darjeeling, 2) Asife Hashmi (29), S/O- Md Munna of Gurung busty, Near Kali mandir, P.S.- Pradhan nagar, Dist- Darjeeling and disclosed our identity and informed them about the information in hand and requested them to accompany us in the whole process of search and seizure if necessary. Accordingly as shown and identified by the source I apprehended the person namely Bijan Das (26), S/O- Ashu Das of Champasari more, Anandamoyee Colony, PS Pradhannagar Darjeeling. I then gave him option in writing whether they wanted to be searched in presence of Executive Magistrate or by any Gazetted Officer. Then he agreed to be searched by one of them. Further I served them a notice in accordance with provisions of law in this regards. Accordingly I informed the matter to I/C Pradhannagar PS & requested

him to come at the spot to remain present and to supervise the search and seizure being the gazetted officer. At 21.55 hrs Sri Subhasish Chaki, I/C Pradhan nagar P.S. reached at the spot and in presence of him and the cited witnesses search was conducted and above noted Drugs capsules recovered from white colour carry bag from the possession of accused person namely Bijan Das (26), S/O- Ashu Das of Champasari more, Anandamoyee Colony, PS- Pradhannagar Dist-Darjeeling and all the above noted article have been seized and labelled in presence of above noted cited witnesses. On demand the accused person failed to produce any valid document in support of the recovered drugs. The accused Bijan Das has confessed that he obtained the consignment of drugs capsules with a view to sell/distribute at local area. Hence I took him into custody after obeying all the guidelines of Hon'ble Apex Court regarding arrest. The seizure was made in between 22.05 hrs 22.40 hrs.

Consequently, the apprehended person namely Bijan Das has been arrested by me at 22.45 hrs by issuing a proper Memo of Arrest and returned back to P.S. at 22.55 hrs vide Pradhan nagar P.S. GDE No 937, Dated-18.05.2021.

Hence it is prayed that a specific case may kindly be started against the accused person namely Bijan Das (26), S/O- Ashu Das of Champasari more, Anandamoyee Colony, P.S.- Pradhannagar, Dist-Darjeeling and arrange for its necessary investigation.
