Order in c/w Covid-19 pandemic as declared by the State Govt by the State Government vide No. 647-ISS/2M-22/2020, dated - 15.05.2020. Accordingly, I warned them but they did not pay heed any words and my lawful instruction as such, I arrested them observing all sorts of arrest rules.
